## Patient Acknowledgment In-Network Benefit Verification

In-network providers are contracted with insurance companies to provide services at pre-determined rates. Out-of-network providers are not contracted and have not agreed to discounted rates. If you are utilizing an out-of-network provider and/or facility, the cost of care can increase substantially. To ensure you obtain full benefits from your insurance plan, it is important that you contact your insurance company directly to verify in-network coverage so you can make an informed decision about your care.

Due to the number of insurance plans and varying networks, it is impossible for Twin Cities Orthopedics (TCO) to be able to confirm in-network coverage for all patients. There are times when TCO will be considered in-network, but the facility (i.e., hospital, ambulatory surgery center) will not be for your plan. It is important to ask your insurance company about the physician and facility where your services are being performed.

Twin Cities Orthopedics is here to answer any questions you may have and help guide you through this process. A list of hospitals and ambulatory surgery centers where TCO performs procedures is on the back of this form. Your Care Team will circle the facility or facilities of where your surgery may be performed. You will need this information when you are calling your insurance company to confirm if the facility is included in your network. You can contact your insurance company by calling the Customer Service number on the back of your card.

By signing this form, you are acknowledging it is your responsibility to contact your insurance company directly to verify if the physician/provider and/or facility are considered in-network for your health plan.
